- To operate on any subsisting banking account and on any new banking account 7. and to draw, make, accept, execute, endorse, discount, negotiate, retire, pay. satisfy, issue and assign cheques, drafts, orders for payments or delivery of money, bills of lading, bills of exchange, promissory notes, hundles, interest and dividend warrants and other negotiable or transferable instruments or securities.
