It is to inform that, as per the instructions of the Prl. Chief Conservator of Forests (HoFF), AP, Guntur vide reference 3rd cited, a demand notice was noticed through reference 5th cited to the Deputy General Manager, Powergrid Corporation of India Ltd. Badvel for payment of the levies mentioned in the Stage Lapproval.

Accordingly the General Manager, Kanigiri had submitted a report through reference 6th cited, that the said amount of Rs. 356.604 lakhs as was mentioned in the demand notice was paid through e-payment mode through NEFT in Adhoc CAMPA Account as per MoEF Guidelines. Further it is to inform that, vide reference 7th cited, the Prl. Chief Conservator of Forests (HoFF), AP, Guntur instructed that as per the GOI, MoEF & CC, New Delhi F. No. 5-3/2007-FC, dated: 05-02-2009 guidelines "in case the forest area proposed for diversion is falling in protected areas, then NPV is to be collected ten times in case of National Parks and five times in the case of sanctuaries respectively of the NPV payable for such areas".

Therefore the Deputy General Manager, Powergrid Corporation of India Ltd. Badvel is requested to pay additional four times of NPV amount pertaining to an extent of 27.744 ha forest land falling in Tiger Corridor of Kancherlamoram RF of Proddatur (WL) Division. The payment should be made through e-payment mode i.e. challan generated through the Ministry's website portal (i.e. www.forestelearance.nic.in) in Adhoc CAMPA as per the guidelines issued by the Adhoc-CAMPA, New Delhi letter dated: 09-06-2016.
