### **Babar machi Rehabilitation Note**

For Rehabilitation of village Dicholi Tal. Patan Dist. Satara due to Koyna sanctuary and Sahyadri Rehabilitation was done on 85 ha. Of disforested area of village Babarmachi Tal. Karad Dist. Satara but after carrying survey work of that land it is observed that 24 ha. Land is only hilly area and that much 24 ha. Area is not suitable for farming or any other purpose for project affected persons. Rehabilitation of total 63 project affected khatedars of village Babar machi Tal. Karad as above the procedure for giving residential plots and munciple services was going on at rehabilitated village Babar machi Tal. Karad Dist. Satara. 1 acre agriculture land is available for each of 63 khatedar and remaining 1 acre of agriculture land is given to khatedar from these two villages - wagheri and karavdi tal. Karad laying so far 12 to 15 km from rehabilitated gaathan.

To gain the remaining half acre agriculture land, project affected persons have given letters in written on tour program of Hon. Chief Secretary (Forest) and requested to show forest land as above. Hon. Chief Secretary (Forest) has directed on 15/8/2013 to Hon. Chief Conservator of Forest (Wildlife) to available remaining half acres of agriculture land at any other places remaining from 24 ha. From forest land by forest department. As above letter by Hon. Chief Conservator of Forest (Wildlife) letter no. B/desk-11/koyna/rehabitation/870/2013-14/Kolhapur dated 20/8/2013 to make available half acre area for each person from remaining 24 ha. Of village Babarmachi, forest land from satara district was shown on another places to project affected persons by forest officers and staff. But no suitable land was found for agriculture. So in 2013 forest land from village Khambale (Bhalawani) tal. Vita - Khanapur dist. Sangli was shown to project affected khatedars. As this project khatedar has choosed it by gram sabha tharav.

To give remaining half acres of agriculture land to project affected khatedar of village Babar machi, As choosed in 2013 from village gram sabha tharav has been given for diverting. for submitting disforestation proposal, project officers has visited the land personly on 18/02/2017 and survey work is done on 22/2/2017 by Sangli forest surveyor. After that preparation of maps, toposheets etc. is done and supplied to you. After that on the order by Chief Conservator of Forest (Wildlife) visited with dy. Conservator of Forest on the spot were work is going on for bio diversity project by social forest department and seen the possibilities to give alternative land to project affected. As per direction on 17/6/2017 dy. Director sahyadri tiger reserve Kolhapur at Karad and representative of social forest department with project affected after watching the land confirmed to you to send disforestation proposal of demanded land. On 17/6/2017 meeting was carried out in the office of hon. Mr. Arvind Patil, Chief Conservator of Forest (T) for Koyna sanctuary rehabilitation.

In year 2013 koyna sanctuary affected were choosed the land of village Khambale (Bhalawani) tal. Khanapur Dist. Sangli for agriculture land under rehabilitation. But in meeting project affected representative -- - said that the said land is handed to social forest department in 2015 for bio diversity project .for this Chief Conservator of Forest (T) has orderd as this - the work on bio diversity project should stop further and it is orderd that the land disforestation proposal of village Khambale (Bhalawni) should send within 15 days to Chief Conservator of Forest (T) Kolhapur.
