Whereas various agreements are to be executed and various permission are to be obtained from various Govt/ Semi Govt or local authorities for and behalf of the Railways from time to time . and where as Mandal Office , Bikaner of Railways appoint official the Gram Panchyat Siha as its Attorney to act on behalf of Railway in the manner and the extent hereafter appearing .

- (b) To purchase and Pay for Stamp Papers / Stamp Duty . for execute agreements .
- (c) To appear before a appropriate authority where needed .

(d) To sign & make all application for seeking all permissions from various authorities where needed . such as PWD , Irrigation Deptt , fire, health , Pollution authority etc .

(e) Now Pandey (Vikram Singh Pandey ) authorised Sh Subedar Lal Singh, Panchan Committee of village Panchyat SIHA. to do the following acts :-


(i) To sign and execute all agreements including lease MOU , declarations , affidavit , undertaking etc .

(ii) To purchase and pay for stamp papers / Stamp Duty as required to execute agreements .

(iii) To appear before appropriate authorities where needed and sign affidavit and undertaking as required for having the halt of Railway between Railway Station Dahina -Zainabad and Railway Station Nangal Mundi near Village SIHA . Distt Rewari .

(iv) To sign and Make all applications and correspond-  
ence for seeking permission from Various authorities .

(v) to do all incidentials , ancillary , related and connected acts & deeds .





