



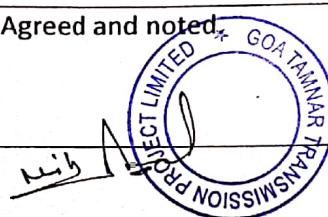

12	The period for diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.	Agreed and noted.
13	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department, or person without prior approval of Government of India.	Agreed and noted.
