
उपरोक्त संदर्भित पत्र (1) द्वारा विषयांकित प्रस्ताव में इस कार्यालय द्वारा सैद्धांतिक स्वीकृति जारी की गई थी। संदर्भित पत्र (2) द्वारा आवेदक संस्थान ने विषयांकित प्रकरण में जारी सैद्धांतिक स्वीकृति का पालन प्रतिवेदन इस कार्यालय को भेजा है। पालन प्रतिवेदन के अनुसार आवेदक संस्थान द्वारा प्रकरण में नेट प्रजेण्ट वैल्यू की राशि रु0 3,38,040/- ई-पोर्टल के माध्यम से भुगतान कर दी गई है तथा आवेदक संस्थान द्वारा सैद्धांतिक स्वीकृति का पालन प्रतिवेदन भी ई-पोर्टल पर अपलोड कर दिया गया था किन्तु पालन प्रतिवेदन हस्ताक्षरित अपलोड नहीं होने के कारण हार्डकॉपी में भेजने हेतु निर्देश दिए गए थे, जिसके पालन में इस कार्यालय को उपलब्ध करा दिया गया है।

अतः सैद्धांतिक स्वीकृति के पालन प्रतिवेदन के आधार पर औपचारिक स्वीकृति निम्नलिखित शर्तों के अधीन प्रदान की जाती है :-

- 1- Legal status of the forest land shall remain unchanged.
- 2- Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency.
- 3- User agency shall restrict the no felling of trees.
- 4- The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 5- No labour camp shall be established on the forest land.
- 6- User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- 7- The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.

- 8- No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 9- The forest land shall not be used for any purpose other than that specified in the project proposal.
- 10- No work shall be done during night.
- 11- The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 12- Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11- 42/2017-FC dt 29/01/2018.



TO WHOMSOEVER IT MAY CONCERN

In Compliance of the Ministry of Environment and Forest (MoEF) Government of India's letter no. 11-9/98-fc (pt) dated 3rd August 2009 where in the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act. 2006 (FRA for short). on the forest land proposed to be diverted for non forest purposes, it is certified that 0.54 hectares of forest land proposed to be diverted in favor of Public health Engineering Department for Construction of Main balancing reservoir (MBR) and overhead tanks in Rajgarh district falls within jurisdiction of Bhojpur, kalikabey, Jaysinghpura, Haripura, Malharpurea Villages in Khilchipur & Jirapur Tehsil.

It is further certified that :-

- (A) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.54 hectares of forest land proposed for diversion. A Copy of records of all consultations and meetings of the forest rights committees, gram sabha, sub division level committee and the district level committee are Annexure 01 and 02.
- (B) The proposal for such diversion (with full details of the project and its implication in vernacular/local language) have been placed before each concerned gram sabha of forest dwellers who are eligible under the FRA.
- (C) The each of concerned gram sabha has certified that all formalities/ processes under the FRA have been carried out and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if and having understood the purpose and details of proposed diversion A Copy of certificate issued by the gram sabhas, of Bhojpur, kalikabey, Jaysinghpura, Haripura, Malharpurea villages is enclosed as annexure 01 and 02.
- (D) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the member of gram sabha present.
- (E) The diversion of forest land facilities managed by the government as required under section 3 (2) of the FRA have been completed and the gram sabhas have given their consent to it.
- (F) The rights of primitive tribal groups and pre-agricultural communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA
