With reference to the above subject, the Government of India vide Ref (1) has accorded 'in-principle' (Stage-I) approval under Section 2 of Forest (Conservation) Act, 1980 subject to certain conditions stipulated therein. The same wascommunicated

by this office vide Ref (2) to the User Agency and field officers seeking Compliance Report in respect of conditions of Stage-I approval.

In response, the User Agency vide Ref (3) has submitted the condition-wise Compliance Report along with relevant document in respect of conditions of Stage-I approval to the Deputy Conservator of Forests, Tumakuru Division, who vide Ref (4) has, after verification, submitted itto Chief Conservator of Forests, Hassan Circle and who in turn has vide Ref (5) submitted the same to this office.

Based on the report received from the field officers, the status of the conditionwise compliance in respect of conditions of Stage-I approval is as follows.
