विषय:- जनपद गोरखपुर में भारतीय राष्ट्रीय राजमार्ग प्राधिकरण (पीआईओयू) गोरखपुर द्वारा सोनौली-गोरखपुर राष्ट्रीय राजमार्ग २९ई के किमी० ०.०० से किमी० ८१.२०४ तक के ४ लेन चौड़ीकरण में प्रभावित ८.३१३७ हे० आरक्षित वनभूमि एवं ०.०६०९ हे० अवर्गीकृत वन भूमि कुल ८.३७४६ हे० वनभूमि के गैर वानिकी प्रयोग एवं बाधक ८४९ वृक्षों/पौधों के पातन की अनुमति के सम्बन्ध में।

महोदय,

उपरोक्त विषयक के सम्बन्ध में अवगत कराना है कि विषयांकित प्रस्ताव के सैद्धांतिक स्वीकृति उप महानिरीक्षक केन्द्रीय, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, क्षेत्रीय कार्यालय लखनऊ के पत्रांक- ८बी/यू०पी०/०६/२८५/२०२२/एफ.सी/७९४ दिनांक-३०.१२.२०२२ (प्रति संलग्न) द्वारा निम्न शर्तों/प्रतिबन्धों पर प्रदान की गयी है। अतएव कृपया सैद्धान्तिक स्वीकृति में लगायी गयी शर्तों का बिन्दुवार अनुपालन आख्या ५ प्रतियों में इस कार्यालय में उपलब्ध कराने का कष्ट करें, जिससे बिन्दुवार अनुपालन आख्या मुख्य वन संरक्षक/नोडल अधिकारी उ०प्र० लखनऊ को प्रेषित कर विधिवत स्वीकृति निर्गत करने का अनुरोध किया सके। बिन्दुवार शर्तें निम्नवत् हैं:-

1. Legal status of the forest land shall remain unchanged.
2. Compensatory afforestation shall be taken up by the Forest Department in total area of 16.75 ha degraded forest land in Bharivaisi Compartment no 4 Range- Campierganj District Gorakhpur at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
3. The geo-coordinates of area proposed for diversion including complete alignment of forest area as well non-forest area shall be uploaded PARIVESH portal.
4. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land cost **Rs. 5945000.00** shall be deposited in advance with the Forest Department by the project authority. The CA plantation will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for work scheduled for subsequent years.
5. The State Government shall charge the Net Present Value (NPV) for the **8.3746 ha X 1436670.00=12031537.00** forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (p) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009.

Revised amount of NPV as applicable as per orders dated 06.01.2022 and 19.01.2022 shall be deposited by User Agency in this regard.

6. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish on undertaking to this effect.
7. User agency shall restrict the felling of trees to 849 tree/minimum numbers in the diverted forest land the tree shall be felled under strict supervision of the State forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
8. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
9. No Violation of FCA Certificate from concerned DFO shall be provided.
10. Plantation shall be raised on both sides of the road and median (available) by the State Forest Department at the cost of User Agency as per submitted scheme according to IRC guidelines and order passed by NGT in OA no.27/2015 in the matter of Babulal Jaju v/s State of Rajasthan and Other dated 16.11.2015

उक्त के कम में आप द्वारा प्रस्ताव में प्रस्तुत किये गये रू0 77853510.00 धनराशि की प्राक्कलन के अनुसार रू0 77853510.00 (रू0 सात करोड़ अट्ठत्तर लाख तिरपन हजार पांच सौ दस मात्र) का बैंक ड्राफ्ट जो किसी राष्ट्रीयकृत बैंक से निर्गत किया गया हो को अधोहस्ताक्षरी के पदनाम प्रमाणीय वनाधिकारी, गोरखपुर वन प्रभाग, गोरखपुर के नाम से इस कार्यालय में उपलब्ध कराने का कष्ट करें।

11. Speed regulating signage will be erected along the Road at regular intervals in the Protected Areas/ Forest Areas.
12. The user agency shall provide suitable under/over pass in Protected Area/Forest Area as per recommendations of CWLW/ NBWL/ FAC/ REC.
13. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act , 1986 , if applicable.
14. The layout plan of the proposal shall not be changed without prior approval of Central Government.
15. No labour camp shall be established on the forest land.
16. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
17. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest officer.
18. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
19. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
20. The forest land shall not be used for any purpose other than that specified in the project proposal.
21. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
22. The KML file of the area to be diverted, the CA areas. The proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e- Green watch portal with all requisite details before commencement of works.

23. Any order of Temporary Work Permission in case of linear projects for tree cutting and commencement of work as per clause 11.2 of FCA Guidelines shall be passed under intimation to Nodal office and this office. Order of Temporary Work Permission have to be uploaded on PARIVESH Portal as well. Nodal Officer will strictly monitor and ensure that no further activity is carried out under such permission after the expiry of one year from the date of issue of such permission.
24. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F.N 11-42/2017-FC dt. 29/01/2018.
25. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
26. All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through e-Portal (<https://Parivesh.nic.in>).
27. The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in>).

After receipt of compliance report on fulfillment of all of the above conditions from the State Government proposal will be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980. by this office.

The order for transfer of forest land to user agency shall not be issued by the State Government till final approval order for diversion of forest land is issued by Government of India.
