Subject: Diversion of 0.1981 ha. of forest land in Sy.No. 33 of Chitradurga village (City), Kasaba Hobli, Chitradurga Taluk and District for construction of Break Pressure Tank (BPT) and Raising Main Pipe Line for supply of drinking water from Vani Vilasa Sagara to Chitradurga under AMRUT Scheme in favour of the Municipal Commissioner, City Municipal Council, Chitradurga.

Sir,

I am directed to refer to the State Government's letter No.FEE 94 FLL 2018 dated 29/01/2019 and 17/01/2020 seeking prior approval of the Central Government under Section'2' of the Forest (Conservation) Act, 1980 for the above project.

After careful examination of the proposal of the State Government, the Central Government hereby conveys the in-principle approval (**Stage-I**) for diversion of 0.1981 ha. of forest land in Sy.No. 33 of Chitradurga village (City), Kasaba Hobli, Chitradurga Taluk and District for construction of Break Pressure Tank (BPT) and Raising Main Pipe Line for supply of drinking water from Vani Vilasa Sagara to Chitradurga under AMRUT Scheme in favour of the Municipal Commissioner, City Municipal Council, Chitradurga, subject to fulfillment of the following conditions:-


1. The legal status of forest land shall remain unchanged.
2. The boundary of the forest land to be diverted shall be suitably demarcated on ground at the project cost as per the directions of concerned Divisional Forest Officer.
3. The State Government shall charge the Net Present Value for 0.1981 ha. of forest area to be diverted under this proposal from the user agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995.
4. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the user agency. The user agency shall furnish an undertaking to this effect.
5. All the funds received from the user agency under the project shall be transferred /deposited to CAMPA fund only through (<https://parivesh.nic.in/>).

6. The layout plan of the proposal shall not be changed without prior approval of Central Government.
7. No labour camp shall be established on the forest land.
8. The forest area shall be used for the purpose for which it is granted. The total forest area utilized for the project shall not exceed 0.1981 ha.
9. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.
10. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
11. The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>).
12. Any other condition that the Ministry of Environment, Forest and Climate Change may stipulate from time to time in the interest of conservation, protection and development of Forest and Wildlife.
13. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F.No.11-42/2017-FC dated 29/01/2018.
14. The State Government and user agency shall comply the provisions of all the Acts, Rules, Regulations, Guidelines, NGT order & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

After receipt of the compliance report on the above conditions, the proposal will be considered for final approval. This in-principle approval shall be valid for a period of 5 years. The forest land shall not be transferred to the User Agency prior to the issue of final approval.
