DEMAND NOTICE

Sub:- TS- Forest (Conservation) Act 1980- Proposal for diversion of 0.6383 Ha of Forest land in Mulugu and WLM Eturnagaram Forest Divisions (0.5729 Ha) of WLM Eturnagaram Division) of Mulugu District in favour of M/s Reliance Jio Infocomm Limited - for laying of Optical Fiber Cable along the road and within the existing Right of Way- in favour of M/s Reliance Jio Infocomm Limited- – In-Principle (Stage-I) approval – **Demand notice Issued** – Regarding.

With reference to the subject cited above, it is submitted that vide reference 5th cited the Principal Chief Conservator of Forests, (HoFF) Telangana, Hyderabad has communicated In-principle (Stage- I) approval for Diversion of 0.6383 Ha. of forest land in Mulugu and WLM Eturnagaram Forest Divisions (0.5897 Ha. of WLM Eturnagaram) in Mulugu District for laying of Optical Fiber Cable along the road and within existing Right of Way – in favour of M/s Reliance Jio Infocomm, Hyderabad and requested to submit the demand for vetting of the Nodal Officer (FCA).

In this regard, it is submitted that for diversion of above said forest land, the said area falls under the jurisdiction of WLM Eturnagaram Division and out of 0.6838 Ha an area of 0.5729 Ha is falling in WLM Eturnagaram Division in Mulugu District and the area details area as follows.

Further it is submitted that, as per the Government of India condition No. (vii) the user agency should compulsorily deposit the NPV and CA into Adhoc CAMPA account of Telangana by generating challan through the Ministry's website. Further it is submitted that, as per the Circular instructions 3/2017 and 5/2017., erecting of Reinforced cement concrete pillars have been calculated and the cost has to be paid by the user agency in Forest Divisional Officer, WLM Eturnagaram, Union Bank of India Mangapet Branch Ac. Further, as per the as recommended by the Standing Committee of NBWL vide Ministry's letter No. 6-69/2017/WL, dated 02.06.2017, and as approved by the Principal Chief Conservator of Forests, WL, CWW, TS, Hyderabad, in the Rc.No.1274/2014/WL-1, Dt: 31.10.2020, the UA has to deposit an amount of Rs.45.00 Lakhs towards Wildlife Mitigation measures in A/c No.110310100030284, Union Bank of India, Secretariat Branch, Hyderabad, IFSC Code: UBIN0811033 in the BIOSOT (Bio-Diversity Conservation Society of Telangana). 1. Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:
2. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.

Further the user agency i.e., M/s Reliance Jio Infocomm Limited, Hyderabad has to furnish the copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

The user agency M/s Reliance Jio Infocomm Limited, Hyderabad is further requested to comply with the other conditions as directed in reference 1st and 2nd cited and submit the compliance report on the conditions stipulated by the Govt. for obtaining Stage II (Final) approval.

Further it is submitted that vide reference 9th cited M/s Reliance Jio Infocomm Limited, Hyderabad ~~it is~~ requested for issue the Demand Notice with current date for further process of payment as the Demand Note validity 60 days from the date of issuance, where the earlier issued Demand Note on 20.11.2021 vide reference 7th cited cannot be processed now for payment, due to demand notice validity was expired.

In view of the above facts, the User Agency M/s Reliance Jio Infocomm Limited, Hyderabad is requested to deposit the above demand amounts in the connected Bank Accounts as mentioned above and submit the copy of the receipts to this office for taking further course action in the matter.
