

With reference to this office memo on the subject cited above, it is to inform you that the financial outlay for CA Scheme over an area of **10.785 ha of Revenue Forest Land** identified in **Rekhapali village** under your Forest Division pertaining to the above project amounting to Rs.23.98,400/- (Rupees Twenty three Lakhs ninety eight thousand four hundred) only approved by Addl. PCCF (FD & NO, FC Act) at the wage rate of Rs.213.50/- per man day with 10 years maintenance.

Due to enhancement of wage rate the above financial outlay of CA scheme has been revised at the wage rate of Rs.315/- per MD and approved by Chief Conservator of Forests, FD & NO FC Act for **Rs.54,54,700/-** (Rupees Fifty four lakhs fifty four thousand seven hundred) only. The approved financial outlay for the above project is enclosed herewith for information and necessary action.



With reference to this office letters on the captioned subject cited above, it is to inform you that you have already deposited the Compensatory Afforestation Scheme amount of Rs. 2398400/- (Rupees Twenty three lakh ninety eight thousand four hundred) only through e-portal on dated 05.05.2018 in the old wage rate @ Rs.212.50/-. In the mean while Govt. has enhanced the wage rate @ Rs.315/MD w.e.f. as per Notification No.5639 dated 02.11.2021 of the Labour Commissioner, Odisha. Now, the revised Compensatory Afforestation amount comes for Rs. 54, 54, 700/- as per wage rate of 315/MD with provision of planting of 18 months seedlings. A copy of Technically Approved Compensatory Afforestation Scheme by the Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act is enclosed herewith for your reference.

You are, therefore, requested to make the balance Compensatory Afforestation amount of Rs. 30,56,300/- i.e. (Rs. 5454700 - Rs. 2398400= Rs. 3056300/-) through e-portal immediately and report the fact of deposit to the undersigned for taking further action at this end.

This should be treated as most urgent.
