Sir,

With reference to the subject cited above, I am enclosing herewith the letter no FOR.33/2022/56 dated 24/08/2022 received from Secretary Govt of Meghalaya Forest and Environment Department inform you that Government has conveyed its Stage I Approval for the Diversion of 0.11 Ha of Forest Land for Proposed for providing potable drinking water to Air Force Eastern Air Command located Complex at Laitkor Protected Forest, (Copy of Stage -I approval is hereby enclosed).

In this regard I would like to request you to comply with the following conditions:-

1. As per point 3 of the Stage I approval, you shall pay the cost of raising Compensatory Afforestation amount to Rs 88,194/- (Rupees Eighty Eight Thousand One Hundred Ninety Four only) and Net Present value (NPV) of Rs 1,58,038/- (Rupees One Lakhs Fifty Eight Thousand Hundred Thirty Eight only) respectively by transferring / depositing into the CAMPA fund through e-portal (<https://parivesh.nic.in/>).
2. As per point no 9 of the Stage I approval, you shall transfer the cost of demarkation pillars of numbers amounting to Rs 5,51,300/- (Rupees Five Lakhs Fifty One Thousand Three Hundred only) respectively by cheque into the current A/c of The Divisional Forest Officer, East Khasi Hills & Ri-Bhoi (T) Division, Shillong, A/c No.30852745780.
3. Also, I am to instruct you to issue Compliance Report on all the conditions laid down in the Stage-I approval.
