- Now since the amount of CA & NPV has been deposited by the user agency. After careful consideration of the proposal, final approval of the State Govt. is hereby conveyed for diversion of 0.6800 ha of forest land for the above mentioned project subject to the following conditions:-
 - 1. Legal status of the forest land will remain unchanged.
 - 2. Compensatory Afforestation will be carried out in Parang (Barshani) over 1.40 degraded forest land as per proposed scheme. Plantation will be done within one year from the date of issue of this letter.
 - 3. No trees felling is involved over the forest land proposed for diversion.
 - 4. The forest land will not be used for any purpose other than mentioned in the
 - 5. No damage of any kind will be caused to the adjoining forest area and all the protection/preventive measures of stability of the area will be strictly adhered
 - 6. Muck/Debris generated during the construction, will be properly disposed, and not rolled down along hill slope.
 - 7. Demarcation of lease area to be done on the ground at project cost using four feet high rainforced cement concrete pillars with serial numbers, forward & back bearings and distance from pillar to pillar.
 - 8. The user agency will abide any condition that may be imposed by the State Forest Department in the interest of the protection and development of the
