The Government of India vide Ref (1) above has accorded *in-principle* (Stage-I) approval for diversion of 0.0824 hectare of forest land in Sy No. 121 of Subramanya village, Subramanya Reserved Forest, Panja Hobli, Sulya Taluk, Dakshina Kannada District for laying of pipeline to provide drinking water in favour of Sri Sri Vidya Prasanna Theertha Swamiji, Jagdguru Sri Madhvacharya MahaSamsthana, Sri Samputa Narasimha Swamy Sri Subramanya Matha, Subramanya, Sulya Taluk, Dakshina Kannada District subject to fulfillment of certain conditions.

Based on Stage-I approval for the project, the Government of Karnataka vide Ref (2) has directed to submit Compliance Report in respect of conditions of Stage-I approval.

In response, the Deputy Conservator of Forests, Mangaluru Division and Chief Conservator of Forests, Mangaluru Circle, after obtaining the 'Compliance Report' from the User Agency, have verified and submitted the same vide letters cited under Ref (3) & (4), respectively.

Based on the reports received as above, the status of compliance to the conditions of Stage-I approval is as under.
