It is submitted that the Conservator of Forests, Adilabad vide reference 20th cited has furnished the condition-wise compliance report in (4) sets, for according necessary approval U/s 2 of Forest (Conservation) Act, 1980 for diversion of 24.7539 ha (against 189.6808 ha proposed) in Asifabad, Bellampally and Kagaznagar divisions for laying of new third BG railway line along the existing tracks within the railway boundary between Makhudi and Rechni road railway stations in Komarambheem Asifabad and Mancherial districts in favour of South Central Railway, Secunderabad. A copy of reference 20th cited together with its enclosures is enclosed herewith.

Compliance to the additional conditions and mitigation measures recommended by NTCA as stated by IGF(WL) in the NBWL meeting are as follows:

1	<p>As a compensation mechanism for the establishment of the third BG line, the concerned railway authority needs to purchase lands (in a continuous stretch) adjacent to the potential corridor/ Habitat linkage area to facilitate movement of tiger and other species in the landscape. Once purchased, these lands will be handed over to forest department for their appropriate management. An onsite survey to identify the best sites including their extent in the proposed land purchase area would be carried out by Telangana Forest Department and concerned Railway division. The matter was discussed with Member Secretary, NTCA who was present in the meeting. The NTCA also prescribed a minimum of 15-20% of the railway line should be covered by the wildlife passage ways at each corridor.</p>

	<p>Further, vide ref 21st cited, the PCCF (HoFF) & CWLW has addressed the letter to the Member secretary, NBWL and informed that there are already two BG railway lines existing and the proposed line is the third BG line being laid to meet the requirement of increased railway traffic on this important route connecting southern Indian states to New Delhi. Since, the new line will be running parallel to the existing two line it would not be possible to change the alignment or the under passes below the existing lines and on request of UA on modifications of the condition in the minutes of meeting by incorporating the passage plan submitted by UA and recommended by CF, Adilabad. However, the reply is awaited from GoI.</p>

The UA has also published the Stage-I forest clearance granted in verbatim along with the conditions and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English and copies enclosed.

On deposition of funds by the UA, and compliance to the other conditions required for issuing of working permission, vide ref 22nd cited, the Working permission has been issued for tree cutting and commencement of works in accordance with the powers delegated to the undersigned.

In view of the above, the Government is requested to forward the interim condition-wise compliance report to Government of India, Ministry of Environment & Forests and Climate Change, Integrated Regional Office, Hyderabad.
