Sub: - Diversion of 5.858 ha. forest land for construction of 3rd railway line from Vizianagaram to Titilagarh over a length of 264.60 Km. passing through Vizianagaram district of Andhra Pradesh and Rayagada, Kalahandi & Balangir district of Odisha by Rail Vikash Nigam Limited (RVNL).

In inviting a reference to the above cited memo no. on the captioned subject and in view of the instruction issued by the Conservator of Forests (Nodal), O/o. the Principal Chief Conservator of Forests, Odisha in his memo No.16678 dated. 27.09.2021, you are requested to deposit an amount of **Rs. 72,07,500/-** (Rupees Seventy-two lakh seven thousand five hundred) only towards C.A. scheme cost over an area of 12.0 Ha. of degraded forest land identified in Baliakhada RF of Tikiri Range through online portal into Ad-hoc CAMPA Account. The RTGS receipt along with the UTR number in support of the above payment may please be submitted to this office for taking further action at this end.

Moreover, as per provision laid down in the above mentioned memo in Sl. No.3 of the financial outlay of Rs. 25,00,000/-, you are requested to provide an vehicle within the approved cost with 4 XWD facility for mobility of field staff in difficult terrain. The vehicle may please be delivered with proper documents, registration, all accessories, road tax and insurance, etc. in the name of the Divisional Forest Officer, Rayagada Division.

Besides the above, you are requested to deposit Rs. 36,67,108/- (Rupees Thirty lakh sixty-seven thousand one hundred eight) only towards NPV for 5.858 Ha. of area @ Rs.6,26,000/- per hectare being the diverted land coming under Eco-value – Class III (open forest with canopy<0.3) through online portal into Ad-hoc CAMPA Account within 30 days of receipt of this letter. The RTGS receipt along with the UTR number in support of the above payment may please be submitted to this office for taking further action at this end. Further you are also requested to furnish an undertaking to pay the additional amount of NPV if so, determined by the Govt. of India/ State Govt. in future.

You are also requested to furnish the required compliance as stipulated in conditions imposed by GoI, MoEF & CC, Integrated Regional Office, Bhubaneswar in their 'Stage-I/in-principle' approval order No. 5-ORC471/2021-BHU dt. 07.09.2021 to this office for onward transmission to the Principal Chief Conservator of Forests (Forest Diversion & Nodal Officer, FC Act), O/o. the Pr. CCF, Odisha.
