As per the instruction of Principal Chief Conservator of Forests (HoD) in reference 3rd cited above in Principle approval (Stage I) under section 2 of Forest Conservation Act, 1980 for the 0.096 Ha of forest land in Sonalur RF area in Mambakkam village of this division for laying underground electric cable subject to the conditions.

1.As per condition Para (c) in the reference 2nd cited, in the diverted forest area and fresh plantation has to be raised in 0.192 Ha degraded forest area of Sonalur RF of Tiruporur Range at the project cost. Accordingly for raising the fresh plantation 211 trees with its maintenance for a period of 10 years an amount of Rs.3,58,464/- (Rupees Three Lakhs Fifty

Eight thousand Four hundred and Sixty Four only) is arrived at user agency is requested to remit this amount under State CAMPA account.

- 2. Contingency fund to meet out the special nature of works for restocking of plantation in the event of drought, protection of plantation etc., @ 5% of total scheme cost of Rs.17,923/- (Rupees Seventeen thousand Nine hundred and Twenty Three only) User agency is requested to remit this amount under State CAMPA account.
- 3. In respect of condition Para (d) regarding NPV of the diverted forest area it is informed that at the rate of Rs.4.38 Lakhs per ha (as per the guidelines of the Government of India, Ministry of Environment Forest and Climate Change, New Delhi letter No.F-3/2000-FC Dt.05.02.2009) the total cost of NPV for 0.096 Ha it has been arrived at Rs.42048/- (Rupees Forty Two thousand and Forty Eight only) and the same has to be remitted under the State CAMPA account. The user agency has to compulsorily deposit the CA and other levies only by generating challan through the Ministries website.

As per condition Para (f) It is requested to remit an amount of Rs.418435/- (Rupees Four Lakhs Eighteen thousand Four hundred and Thirty Five Only). This amount has to be remitted under the State CAMPA.by generating an online challan for making payment to through e-portal (https://parivesh.nic.in/);
