DEMAND NOTICE

Sub: TSPD-Forest Conservation Act - Diversion of **3.308 Ha.** Of Forest Land in erstwhile Nizamabad Division and presently Banswada forest division - for laying of pipeline and contraction of structures in **Segment-12/2 (Jukkal)** for providing safe drinking water in erstwhile Kamareddy District - under Telangana Drinking Water Supply Project - in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal - In-principle (Stage.I) approval - Demand Notice, - Submitted - Request - Regarding.

It is to inform that EFS & T (For-I) Dept Telangana State vide reference 1st cited has accorded in-principle (Stage-1) approval for diversion of 3.308 ha of Forest land for laying of pipe line and construction of structures in Segment-12/2 (Jukkal), for providing safe drinking water in Kamareddy Districts under Telangana Drinking Water supply project in favour of Superintending Engineer, TDWSP Circle, Nirmal, subject to the compliance of the certain conditions mentioned therein.

As per the conditions stipulated, the User Agency has to make the payment towards the following compensatory levis:

- The legal status of forest land shall remain unchanged.
- The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.
- The User Agency shall pay the Net Present Value (NPV) of the diverted forest land as per the orders of the Hon'ble Supreme court, dtd 28.03.2008 and 9.5.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995 and as per the orders issued by State Government vide

4. Additional amount of the Net Present Value (NPV) of the diverted forest land, if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the user agency. The User Agency shall furnish an undertaking to this effect.

6. The additional amount of the Net Present Value (NPV) of the diverted forest land, if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the user agency and deposited either in SB A/c No.37100101029963 of Corporation Bank, CGO Complex, Lodhi Road, New Delhi -110003 (RTGS/IFSC No.CORP0000371) or SB A/c No.344902010106351 of union Bank of India, Sunder Nagar, New Delhi -110003 (RTGS/IFSC No.UBINO534498).

The User Agency has to deposit a total amount of **Rs.68,98,000 (Rupees Sixty Eight lakhs Ninety eight Thousand only)** the details are as shown in the below table), through e-payment portal only by generating challan at the Ministry's website (<https://forestsclearance.nic.in>) against the project into the Telangana Compensatory Afforestation Funds (CAF)/Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPFA) Saving bank Accounts maintained in either of the Banks mentioned below under intimation to this office with proofs/evidence:

7. The proposals shall be examined under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act,2006 as per the guidelines issued by Ministry of Environment & Forests vide Letter No.11-9/1998-FC (Pt) dated.5-7-2013 and requisite certificates /documents be furnished.
8. Other conditions specified in the GOI,MoEF, letters dated.03.01.2005,13.05.2011,16.6.2011,13.02.214 and 07.11.2014 shall also be completed with by Principal Chief Conservator of Forests, Telangana State, Hyderabad and user agency with which they are concerned.
9. The forest land shall not be used for any purpose other than that specified in the proposals.
10. The forest land to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Government.
11. The User Agency shall be responsible for any loss to the flora/fauna in the surroundings.
12. Any tree felling shall be done only when it is necessary.


13. The total forest area utilized for the project shall not exceed 3.308 ha. In case the land is not taken over by the User Agency or the same is not used for the stipulated purpose within a period of two years, then the area shall be taken back by the Forest Department.
14. The Forest Department may impose fine time to time any other conditions(s) in the interest of conservation, protection and / or development of forests.
15. The User Agency shall put two permanent boards at the entrance and exit points of the Reserve Forests in the said locations about the status of the land also construct boundary pillars separating the proposed area for diversion at every 20 mts interval.
16. The User Agency shall deposit an amount of **Rs.34,66,000** (Rupees Thirty four lakhs Sixty six thousand Only, Construction of Boundary Pillars & Tree growth Extraction and transportation etc., (the details are shown in the below table), in the SB A/c. bearing No. **62491766369**, IFSC Code: **SBHY0020112** of State Bank of India, Banswada Branch, Banswada in the name of **Forest Divisional Officer, Banswada**.





