Sub:- R&B Dept – Diversion of 4.7231 Ha of Forest Land in Kamareddy Division – Improvements to Banswada Upplawai road from km 17/080 to 18/278 & 22/180 to 23/042 in Kamareddy District.- submission of proposals -Initiation of Forest Land Acquisition process -Request – Reg.

It is proposed to take up the work “Improvements to Banswada Upplawai road from km 17/080 to 18/278 & 22/180 to 23/042 in Kamareddy District.”

For this work diversion of forest area required. A detailed Differential Global Position Survey is carried out along with the forest section officers. As per our requirement the total extent of Forest Land is arrived as 4.7231 Hectares in Jurisdiction of Kamareddy forest Division, for which linear diversion of forest land is required. Detailed DGPS survey conducted was submitted vide reference 1st cited. The DGPS survey raw-data submitted was verified and authenticated vide reference 2nd cited.

The proposals are submitted as per the guide lines issued under Forest (Conservation) Act 1980, the project for road construction will be processed in their entirety. Hence the proposals for Acquisition of Forest Land is prepared in the Kamareddy forest Division in the prescribed format, drawing showing the improvements, Longitudinal section and cross section along with Forest map showing the area of land are here with enclosed for kind perusal. Hence, I herewith submit the proposals under Forest (Conservation) Act, 1980 with the required enclosures. A DD Drawn to an amount of Rs.6,000/- in favour of Joint Secretary , CEFNARM, Hyderabad is enclosed here with for authentication charges of ETS & DGPS survey Data.

The present stretch on Banswada Upplawai road from km 17/080 to 28/278, 22/180 to 23/024 was not sanctioned under any scheme till date.

Hence, the proposals for the forest diversion in these stretches were not covered under earlier proposals.

The road is single lane BT road . The traffic on the road is high and it is unable to cater the present traffic volume. It is very much essential to widen the road. In addition to above the forest reach of this road is passing through hill area . Heavy vehicle and public transport vehicle like buses are unable to climb the hills portion of this road .Lots of accidents are taking place at this location. In this regard it is very much essential to improve the road in this stretch . Further, the CA land requirement will be addressed to District Collector and CA land requirement will be submitted in due course.

It is therefore, requested the Principal Chief Conservator of Forests, Aranya Bhavan Hyderabad, kindly to initiate the process of Forest Land Acquisition and also requested to pass necessary orders to the concerned to start the field survey as early as possible for submitting same to the Government for according approval of linear diversion of forest land for geometrical improvements of road in reserve forest.
