Accordingly the proposal for diversion of forest land has been submitted through online portal of Forest Department by this office vide reference 1st cited for getting approval.

Accordingly this office vide references 3rd, 4th, 5th, 7th & 8th cited has requested the District Administration to issue the FRA certificate for the said subject project road which traverse through Pamban Reserve Forest and Rameswaram Reserve Forest as required by Forest Department and the model format for issuance of Form-I Certificate also been enclosed.

In such circumstances, the Sub Collector, Ramanathapuram vide reference 6th cited has submitted the inspection report to District Collector, Ramanathapuram for the area of 7.488 Hectares in forest land. The road width (acquisition) was reduced to 45m from 60m. The DPR consultant had discussion with Special District Revenue Officer, Revenue Tahsildar of Rameswaram on 19.11.2020 the details of forest land required for the project road along with the list of Maps collected from Forest Department. Further, the SF.No.491/6 in Pamban village Reserve Forest land was also confirmed with Forest Range Officer.

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 4.3452 hectare of forest land proposed to be diverted in favour of the National Highways Authority of India for the purpose of 4/6 laning of Ramanathapuram - Rameshwaram - Dhanushkodi section of NH 87 (Old NH No.49) road in Ramanathapuram District falls within the jurisdiction of in Pamban Reserve Forest, Pamban Village (1.077Ha) & Rameshwaram Reserve Forest, Rameshwaram Village (3.267Ha) respectively of Rameshwaram Taluk.
