In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC(pt.) dated 3rd August'2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act,2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes. It is certified that 5 (five) hectares of forest land proposed to be diverted in favour of **Ghagor Mining Contract Area** (Name of user agency) for collection Boulder/Stone (purpose for diversion of forest land) in Lakhimpur District falls within jurisdiction of no forest village(s) in (NA) tehsils.
