



With reference to the above cited correspondence on the subject, it is to inform you that the Government of India, Ministry of Environment & Forests Eastern Regional Office, At: Chandrasekharapur, Bhubaneswar vide their letter No. 5 -ORB428/2020-BHU dt. 24.09.2020 has accorded Stage-I approval for diversion of 1.990 ha of forest Land for Laying of Iron Ore Slurry Pipeline from Barbil to Angul. As per State Government condition No. -xxvi) :- The user agency shall contribute towards implementation of Regional Wildlife Management Plan at the revised rate for the entire area of slurry pipeline alignment.

Hence you are requested to deposit an amount of Rs. 3,00, 284.00 (Rupees three lakh two hundred eight four) only @ 82,000/- per ha towards Regional Wildlife management Plan over 3.662ha non forest land coming within Angul Forest Division through "e" payment on line in Ad-hoc CAMPA in the saving Bank Account No. 520101263743655, Corporation Bank, Lodhi Complex, Ground Floor, Block No. 11, CGO Complex, Lodi Road New Delhi immediately and intimate the same to the undersigned for taking further action in the matter.


Further, you are requested to submit Site Specific Wildlife Conservation Plan as per State Government condition No. (e) Site Specific Wildlife Conservation Plan for the project impact area shall be prepared by the User Agency with emphasis on safeguarding the elephant movements in the applied area of Keonjhar and Deogarh Division and in the non-forest area of Angul Division involved in the project which passes through Kanheijena- Anantapur elephant corridor by the side of Kanheijena Reserve Forest and it shall be implemented at the project cost as per approval of the Chief Wildlife Warden, Odisha immediately for necessary approval of the competent authority.


