In pursuance to the guidelines of MoEF & CC, for diversion of **forest land** for **non-forest purpose**, it is mandatory to take FRA-2006 clearance from the concerned **Deputy Commissioner office** before online submission of the proposal in the MoEF website. Accordingly, proposal for following locations is submitted for your perusal and further necessary instructions /action please.

The six locations **DPDD, DPDH, DPDI, DPDJ, DPDK & DPDL** falls under Golaghat Dist. PML. Total area of the granted PML is 52.12 square kilometre and only **2.7286 Ha.** (for drill site area = 160m x 160m = 2.56 Ha. and its Approach road = 0.1686 Ha.) of land is required to accommodate all the six locations for drilling the above locations. The maximum size of each drilling hole is only 18-20 inch. All the locations are planned to drill from a **Common Point** which co-ordinates are attached herewith and located the site in Dayalpur village area under Dist. Golaghat .


