Please refer this office letter 3rd cited above, wherein it was requested for Re-division of forest land for laying 2 Nos of 220kV XLPE UG cables of LILO of 220kV Gachibowli-Erragadda and LILO of 220kV Gachibowli-Miyapur and diversion of forest land for construction of 1 No cable termination tower for LILO of 220kV Gachibowli-Erragadda near Botanical garden, Kothaguda.

According to the procedure communicated vide ref 4th cited above, the proposal for re-division and diversion of forest land for erection of subject line in the prescribed format along with ETS & DGPS Survey data are herewith submitted for verification and authentication of ETS and DGPS survey data. Further, it is also to submit that the Demand draft for an amount of 3000/- (Rupees Three Thousand Only) in favour of "Joint Secretary, CEFNARM" towards verification and authentication of ETS & DGPS Survey Data was already submitted vide ref 5th cited above the receipt of the same was confirmed vide reference (6) cited above.

In this regard, it is requested to arrange to initiate next action for getting approval of forest clearance as early as possible.
