In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt.) dated 3rd August, 2009 wherein the MoEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Scheduled tribes and other Traditional Forest Dwellers (Recognition of Forest Rights), Act, 2006 (FRA, for short) on the forest land proposed to be diverted for non forest purposes, it is certified that 123.812 hectares of forest land proposed to be diverted in Mothadaka Reserve Forest in favour of Commissioner, APCRDA, Vijayawada for taking Capital City infrastructure Development works in Guntur District, Andhra Pradesh falls within the jurisdiction of Motadaka Village in Tadikonda Mandal.

It is further certified that:

- the complete process for identification and settlement of Rights under the FRA has been carried out for the entire 123.812 hectares of forest land proposed for diversion in Mothadaka Reserve Forest.
- the proposal for such diversion (with full details of the project and its implications, in vernacular/local language) have been placed before each concerned Grama Sabha of forest-dwellers, who are eligible under the FRA;
- The each concerned Gram Sabha(s), has certified that all formalities / processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion.
- the discussion and decisions on such proposal had taken place only when there was a quorum of minimum 50% of the members of Grama Sabha present;
- the diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Grama Sabhas have given their consent to it;
- the rights of primitive Tribal Groups and pre-Agricultural communities, where applicable have been specifically safe guarded as per section 3(1) (e) of the FRA.


