Deposit of Compensatory levies after the grant of Stage-1 ('in-principle') approval in respect of proposal for the diversion 0.3433 ha. forest land in favour of HPPWD, National Highway Division, Pandoh Distt. Mandi, H.P. for the construction of bridge across Beas River in Manali within the jurisdiction of Kullu Forest Division under Forest Conservation Act, 1980.

The 'in-principle' approval to proposal cited as subject has been accorded by Govt. of H.P. vide letter No. 08B/HPB/06/82/2015/497 dated 19-09-2016 (copy enclosed for ready reference) and in pursuance of Pr. CCF, HP's letter No. Ft.48-1730/2013 (B) FCA dated 10-02-2014, brief details of the proposal is as under :-

3. The Compensatory levies mentioned above may be deposited strictly in accordance with the following guidelines :-

(K) **FOR AMOUNT (s) MENTIONED AT 2 (I) TO BE DEPOSITED IN ADHOC-CAMPA ACCOUNT.**

i)To be deposited by you directly through e-payment module of forest clearances portal for online remittance of Compensatory levies. The portal can be assessed through the website of MoEF &CC, GoI "forestsclearance.nin.in" . The procedure have been uploaded in the web page. However, extract copy of steps followed for collection of

CAMPA funds through web portal is also enclosed. The User Agency has option to deposit the funds in either of the following two Banks Accounts given below :-

x) Union Bank of India, Sundernagar, New Delhi-110003 (IFSC No. UBIN0534498 and Saving Account No. SB344902010105419).

y) Corporation Bank, Lodhi Complex Branch, New Delhi (IFSC No. CORP 0000371 and Saving Account No. SBO1025210)

- ii) The amount to be deposited in Adhoc CAMPA account has to be deposited through-payment module only and should be *deposited separately against each forest land diversion proposal. CA/NPV amounts and other levies of two or more cases should not be clubbed and deposited together.*
- iii) After depositing the amount of CA, NPV etc. in Adhoc-CAMPA account through e-payment, the UTR No. & Date of each such transaction shall have to be provided to the Forest Department for reference and not the 'Token No' or Demand Draft No. through which it has been deposited as being done by many user agencies at present.
- iv) While filling the RTGS form of the Bank, the name of user agency shall be correctly filled in the relevant column and the name of so filled shall be same as appearing in the proposal folder.
- v) The amount of CA/NPV *shall not be deposited in old account of Adhoc CAMPA in Corporation Bank, Kasumpti, Shimla* but only in either of the two banks of Delhi, detail of which is given at (i) above.

(B) FOR AMOUNTS MENTIONED AT 2 (II) TO BE DEPOSITED IN STATE GOVT. TREASURY :-

- vii) Amount due towards cost of trees and 17.5% **Departmental Charges** on CA/Addl.CA/Penal CA/Reclamation Plan, @ 17.5% of cost of CA/Addl.CA/Penal CA/R-Plan may be deposited in this office through cheque/DD in favour of Divisional Forest Officer, Forest Division, Kullu payable at Kullu.
- viii) **For amount due towards VAT, it has to be deposited** through e-payment on line with DFO TIN No. 02100100699 and submit the e-challan copy (in original) to this office.
- ix) **Income Tax and Surcharge on Income Tax** may be deposited by you directly against PAN/TAN No. PTLDD11461C Of DFO, Kullu and copy of the receipt of deposition of Income Tax/Sur charge on income tax may be furnished to this office for record.
