(FRAfor short) on the forest land proposed to be diverted for non- forest proposes, it is certified that 0.27 hectares of forests land proposed to be diverted in favour of the Chief Conservator of Forests

(Nodal Officer, ECA, Covers /Nodal Officer, FCA, Government of Manipur for the Project namely for Construction of Global School of Human resources at Nongmaiching Hill, Keirao, Imphal East falls within Nongmaiching Hill, Keirao, Imphal East.

It is further certified that:

(a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.27 hectares of forest area proposed for diversion;

(b) There is no forest dwelling Scheduled Tribes and Other Traditional Forest Dwellers in the entire 0.27 hectares of forest land at Nongmaiching Hiil, Keirao Imphal East proposed for diversion by the Chief Conservator of Forests / Nodal officer, FCA Government of Manipur

(c) The proposed diversion does not affect the recognized right of Forest Dwelling Scheduld Tribes, Other Traditional Forest Dwellers, primitive Tribal Groups and pre- agricultural Communities as the proposed area is not inhabited;

(d) The forest land proposed for diversion by the Chief Conservator of Forests / Nodal officer, FCA Government of Manipur is located at Nongmaiching Hill, Keirao, Imphal East, and lies within the jurisdiction of Keirao Gram Panchayat, Imphal East -II CD Block

(e) The Gram Sabha of Keirao Gram Panchayat has given its formal consent to the proposal for diversion of forest land for Construction of Global School of Human Resources at Nongmaiching Hill, Keirao Imphal East by taking a resolution to that effect in its meeting held on 4th August,

A copy of the resolution of the Gram Sabha in its meeting dated 04/08/2017 is enclosed for reference. This certificate has been issued with appropriate modification to the format prescribed by the Ministry of Forest Land Environment, Government of India vide its letter No. F.No.11-9/98-FC(pt) dated 05.07.2013 in view of the non existence of habitation and interests in the area proposed to be diverted.
