



**TO WHOMSOEVER IT MAY CONCERN**

In compliance of the Ministry of Environment & Forests (MOEF), Government of India's letter No.11-9/98-FC(pt), dated 3<sup>rd</sup> August, 2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MOEF's letter dated 5<sup>th</sup> February, 2013 wherein MOEF issued certain relaxation in respect of linear projects, it is certified that **2.57 Hectares of forest land of the Jamb-kandri Range Reserved Forest Pangri Bit Compartment no. 54 in Tumsar tahsil Bhandara District** proposed to be diverted for the Construction of Feeder Canal to Sorna Medium Project from RD 16500 m of Bawanthadi RBC Main Canal in Mohadi Taluka of Bhandara District and demand for the forest land is minimum.

It is further certified that :

- a) The complete process for identification and settlement of rights under FRA has been carried out for the entire **2.57** hectares of forest land proposed for diversion. - c) The proposal does not involve recognized rights of Primitive Tribal Groups and Pre-Agricultural Communities.
