

With reference to the above cited correspondence on the subject this is to inform you that the Principal Chief Conservator of Forests Odisha, Bhubaneswar has approved the Compensatory Afforestation Scheme over 43.312 hectares of non-forest land in village Sanabudahada, Sikabandha & Sindhupanga under Bisam Cuttack Tahasil of Rayagada district for Rs.1,17,61,000/- so as to comply the conditions No.2(vi) stipulated by Govt. of India, MoEF & C.C. in their letter No.8-58/2017-FC dated 22nd January 2018 while according Stage – I approval for diversion of 44.038 hectares of Forest land for Bainibasa Graphite Mines in Bainibasa village under Bisam Cuttack Tahasil.




