Sub: - Submission of scheme for taking up plantation of DWARF species (Preferably Medicinal plants) under the 220KV S/C transmission line on D/C Towers from existing 220/33 KV sub-station at Laxmipur to premises of NALCO.

As stipulated in the above referred stage-I approval forest clearance order on the subject cited above, you have to deposit an amount of **Rs.80,82,000/-** towards scheme for taking up plantation of DWARF species (Preferably Medicinal plants) against Diversion of 11.377 ha. for 220KV S/C Transmission Line on D/C Tower from existing 220/33KV sub-station at Laxmipur.


In this connection, this is to inform you that, as per guidelines laid down that point No.4 of the Compensatory Afforestation fund management & planning authority which has been communicated by the Addl. P.C.C.F. Forest Diversion & Nodal Office, F.C. Act vide his memo No.13681 dated 18.7.2016 (Copy enclosed) that "After considering all relevant factors it has been decided that no payments by any mode other than the e-payment should be accepted after 13.06.2016, the payments made other than through the e-payment module on or after 1<sup>st</sup>. July, 2016 shall not be taken in to account, the account for the grant of final clearance and/ or working permission under the provisions of the forest (Conservation) Act.1980"

In view of the above facts, you are requested to make payment through e-payment module an amount of **Rs.80,82,000/-** to Ad-hoc-CAMPA Account under intimation to this office for taking necessary action at this end.
