

BASUNDHARA WASHERY

DRAFT REHABILITATION AND RESETTLEMENT PLAN

The lands belonging to village Balinga, Bankibahal and Kushara of Hemgir Tahasil, District-Sundargarh, Odisha are involved in Basundhara Washery Project. The washery project includes the Site for Washery, site for reject storage, Reject conveying corridor & Clean Coal conveying Corridor up to Silo (Railway loading point).

Total 108.48 acres of land is involved in Washery project. Out of that 25.09 acres is tenancy land, 10.71 acres is Govt.(NF) land, 69.28 acres is Revenue forest land and 3.40 acres is RF (Reserve Forest).

Out of 25.09 acres of tenancy land involved in this project, 2.91 belongs village Balinga, 2.55 acres belongs Bankibahal and 19.63 acres belongs to Kushara village. The lands of Balinga and Bankibahal villages have been acquired under CBA(A&D) Act, 1957 and lands of village Kushara are proposed to be acquired under The RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT,2013. Approximately, 85 families from these villages will be displaced/ affected due to this project as per the approved PAF list of village Balinga and Bankibahal and Record of Rights of village Kushara.

Note: The above figure of the families expected to be displaced / affected is based on PAF list of village Balinga and Bankibahal and the ROR of village Kushara. However, the figure may vary after detail family survey of village

Kushara. The Rehabilitation and Re-settlement to the affected families of village Balinga and Bankibahal have been given as per the Odisha R&R Policy 1998. The Rehabilitation to the affected families of Kushara will be given as PER LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT,2013.

Land Compensation: The compensation for land and dwelling houses has already been paid to the affected/displaced families of Balinga and Bankibahal under Kulda OCP of MCL. The land compensation for village Kushara will be made as per The RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT,2013.

R&R benefits to the 22 affected families of village Balinga: As per the eligibility, 16 persons have been given employment in MCL under Kulda OCP & 2(two) families have been given cash against employment as per their choice. Re-settlement benefits/ cash against Resettlement @ Rs 5,32,000.00 have been given to 21 eligible families.

R&R benefits to the 21 affected families of village Bankibahal: As per eligibility, 11(eleven) families have been given employment in MCL under Kulda OCP.2 (two) families have been given cash against employment. As per Odisha R&R Policy. 16 (sixteen) families are eligible for Re-settlement benefits. Out of them, 11 families have been Re-settled in the Re-settlement site at Barpali-1& 5(five) families have been given cash against Resettlement Rs 5,78000.00 each under Claims Commission.

The Hon'ble Supreme Court of India has set up a Claims Commission for determination of compensation for land and determination of the eligibility families for Rehabilitation and Re-settlement benefits for the villagers of Balinga, Bankibahal and 12 other villages. The Commission has already determined the compensation and R&R packages for the left out families Balinga and Bankibahal and the same has already been paid to the families.

Re-habilitation benefits to 42 affected families of Kushara: The affected families for this project will not lose any homestead land and dwelling house. They will lose their agricultural land only in part. The land compensation and Rehabilitation benefits will be given to the affected

families as per the Provisions of The RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013. The provisions of the Policy from page 39 to 45 are enclosed here with as Annexure-1.

CORPORATE SOCIAL RESPONSIBILITY OF MCL

PROVISION OF INFRASTRUCTURAL AMENITIES

For resettlement of populations, the following infrastructural facilities and basic minimum amenities are to be provided at the cost of the Requisitioning Authority to ensure that the resettled population in the new village or colony can secure for themselves a reasonable standard of community life and can attempt to minimise the trauma involved in displacement.

A reasonably habitable and planned settlement would have, as a minimum, the following facilities and resources, as appropriate:
