Madam,

It is submitted that the Ministry of Road Transport & Highways Government of India, New Delhi has proposed to Improve and Widen the Nizampet-Narayankhed-Bider Road of NH-161B to Two Lane with Paved shoulders from km 0.0 to km 49.0 in the State of Telangana.

2. The above road work requires widening and improvements of road geometrics to NH standards in the different forest stretches in between Nizampet- Narayankhed town, for which, an extent of 15.592 Ha. forest land requires diversion in RF Blocks of Jukalkhurdu, Railamadugu and Namelimet in Sangareddy Division for non forest purpose (NH development).
