**Revised Demand Notice**

Sub: - APFD – Forest Conservation Act, 1980 – Proposal for diversion of 2.89 ha. of forest land for formation and BT to the road including construction of culverts from G.Agraharam to Lakkavaram in Pedavalasa RL in Compt.no.1324, 1325, 1329 & 1488 of R.V.Nagar Range in Narsipatnam Division in favour of Executive Engineer, Panchayat Raj, Paderu – In-principle (Stage-I) approval accorded – Orders communicated – Revised Demand notice issued - Reg.

In continuation of this office reference 5<sup>th</sup> cited, the revised demand notice is issued for diversion of 2.89 ha. of forest land for formation and BT to the road including construction of culverts from G.Agraharam to Lakkavaram in Pedavalasa RL in Compt.no.1324, 1325, 1329 & 1488 of R.V.Nagar Range in Narsipatnam Division in favour of Executive Engineer, Panchayat Raj, Paderu with certain conditions.

Hence, the Executive Engineer, (PR), PIU, Paderu is requested to go through the conditions stipulated from (i) to (viii) in the G.O.Rt.no.102, EFS&T (Section-II) Dept., dt.25.07.2018 as per reference 3<sup>rd</sup> cited and also follow the instructions issued by the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur in the reference 4<sup>th</sup> cited without any deviation and publish the entire forest clearances granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspapers one in vernacular language and another in English language so as to make people aware of permission granted to the project proponent for use of forest land for non-forestry purposes. The copies of the Forest Clearance should also be submitted to the Heads of local Bodies,

Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

In the reference 2<sup>nd</sup> cited, the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur has communicated Diversion of forest land for non-forestry purpose Stage-I/II approval accorded Payment of Compensatory levies by user agencies certain anomalies noticed in Demand notices issued by DFOs. Draft Demand Notice Template communicated for NPV and Tree Extraction, Logging and transportation in the forest area diverted as detailed below.

**I. (a) Procedure for e- challan generation:**

- On issue of this demand notice, the user agency shall log in to Forest Clearance portal **forestsclearance.nic.in** to generate e-challan and make payment against the demand.
- Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

**I. (b) Procedure for Payment through RTGS:**

- For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.

- vi. Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.

**II. Amount demanded for Tree extraction, logging and transportation in the forest area diverted to be deposited with Divisional Forest Officer** (As per IGF , Adhoc CAMPA Ir.No.13-20/2015-CAMPA dated : 09-06-2016 communicated vide PCCF 's Rc.No.45921/2001/FCA-4 (ii), dated : 04-07-2016).


