With reference to above letter, requesting revised Demand Note for compliance of conditions of Stage- I Clearance mentioned in government of India's letter. User agency is required to pay following

Condition

2. Compensatory Afforestation

- (a) The State Forest Department shall undertake plantation of 10 times under of mangrove trees to be felled over suitable land as compensatory afforestation in lieu of forest land being diverted at the cost of the User Agency.
- 3. The Cost of Compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey. Demarcation and creation of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the Project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

Compliance

User agency required to pay following (A) and (B) amount in Ad-hoc CAMPA through E-challan in the Saving Bank Account for compliance of conditions no. 2(a), 3. Details as follows.

4. NPV

(a) The State Government shall charge the Net Present Value (NPV) for the 0.035 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the Guidelines issued by the Ministry vide letters No.5-1/1998-FC (pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC Dated 03/10/2006 and 5-3/2007 FC dated 05/02/2009 in this regard.

B) User agency is required to pay Net Present Value for 0.035 ha. of Mangrove Forest Land to be diverted amounting Rs. 25,550/- (Twenty Five Thousand Five Hundred Fifty only). User agency has submitted the undertaking mention that in future if Additional NPV or if any penalty is required to be paid by user agency.

(06) Cost of tree felling.
