- 2. Density-0.04 3. Eco-Class - III
- 4. Rate of NPV per Ha. - Rs.6, 26,000 lakhs.
- 5. Total Amount of NPV - 17.02 x 6, 26,000 lakhs = Rs. 1, 06, 54,520/-
