


UNDERTAKING

Sir,

In inviting a reference to the subject cited above, I am directed to intimate you that Ac.97.850 (39.60 hact) of forest land after diversion will be allotted to M/s BPCL Ltd. for establishment of industry in the village Arda under Kirimira Tahasil of Jharsuguda Dist. As per GoI, MoEF Guidelines it is mandatory to enclose No Objection Certificate from the Collector & District Magistrate under Forest Right Act-2006 in the forest diversion proposal. (form of the certificate is attached)

Further Gramsabha is required to be conducted in the village Arda to obtain consent of the villagers for use of the forest land for non forest purpose.

It is therefore, requested that Gramsabha may kindly be conducted and consent of villagers in form of resolution may be sent to IDCO.

Further the certificate under Forest Right Act-2006 may kindly be issued to IDCO for processing the FDP.
