Kindly refer to Dy. Inspector General of Forests (FC) letter No. Ft. 8-48/2018 (FC) dated 19-9-2018 on the subject cited above.

2. As you are aware that DIG (FC) has accorded stage-I approval, vide his letter under reference subject to fulfilment of the certain conditions. Keeping in view of Stage-I/In-principle approval accorded by the competent authority under Forest (Conservation) Act, 1980 you are requested to fulfil the following conditions:-

vii & ix) Compensatory Afforestation scheme over 108 hectare including 10 years maintenance has been prepared to the tune of **Rs. 2,54,82,303/-** (including Departmental charges). Detail bill enclosed herewith.

x) Bill of **Rs. 63,70,576/-** only including departmental charges for additionally 25% of the Compensatory Afforestation cost towards soil & moisture conservation measures in the proposed CA area is enclosed.

xi) The cost of NPV in lieu of forest land is calculated to the tune of **Rs. 3,77,22,863/-** as per the provision and guidelines issued by the Ministry vide letter dated 05-2-2009.

xii) & xiii) All the funds i.e. cost of CA Scheme for **Rs. 2,18,41,974/-**, additionally 25% of the Compensatory Afforestation cost towards soil & moisture conservation measures for **Rs. 54,60,494/-** & NPV for **Rs. 3,77,22,863/-** (Total amounting to **Rs. 6,50,25,331/-**) respectively be deposited in Ad-hoc CAMPA through online e-portal only. After depositing the said fund copy of e-challan alongwith UTR No. duly attested be submitted to this office. Beside this a **Demand Draft of Rs. 45,50,411/-** as departmental charges be submitted in this office favouring **Divisional Forest Officer, Rampur Bushahr**.

3. The Compensatory levies mentioned above may be deposited strictly in accordance with the following guidelines:-

**(A) FOR AMOUNT (s) MENTIONED at2(I) TO BE DEPOSITED IN ADHOC-CAMPA ACCOUNT**

a. To be deposited by your (user) department / Organization directly through RTGS from your Bank Account (any Bank anywhere in India) which will be accepted through e-payment only in the bank account given below:-

b. The Amount to be deposited in Adhoc CAMPA account has to be deposited online chaltan mode through RTGS/NEFT which will be accepted through e-payment only and should be deposited separately against each forest land diversion proposal. CA/ NPV amounts and other levies of two or more cases should not be clubbed and deposited together.

- c. After depositing the amount of CA, NPV etc. in Adhoc-CAMPA account through RTGS , the UTR No & Date of each such transaction shall have to be provided to the Forest Department for reference through receipt generated online and not the 'Token No' or Demand Draft No through which it has been deposited as being done by many user agencies at present.
- d. While filling the RTGS form of the Bank, the name of user agency shall be correctly filled in the relevant column and the name so filled shall be same as appearing in the proposal folder.
- e. The amount of CA / NPV shall not be deposited in old account of Adhoc CAMPA in corporation Bank, Kasumpati, Shimla but only in the Corporation Bank Lodhi Complex Branch New Delhi-110003, detail of which is given at (a) above.
- f. The compliance report of other conditions of GOI letter dated 18.9.2018 may be fulfilled and submitted to this office alongwith supporting certificates /undertaking at the earliest please so that stage II approval can be obtained from competent authority.

**(B) FOR AMOUNT MENTIONED AT 2 (II) TO BE DEPOSITED IN STATE GOVT. TREASURY:-**



2. Vide letter under reference you were requested to deposit the 1st installment of Luhri HEP CAT Plan to the tune of Rs. 16,53,64,530/- (Rs. 5,63,14860 for the year 2018-19 and Rs. 10,90,49,670/- for the year 2019-20). Now as per clarification got from head office the facility of depositing CAT Plan funds in installments is only for HEP's which are upto 25 MW only. Therefore now total cost of CAT Plan to the tune of **Rs.56,68,34,154/-** is required to be deposited in designated CAMPA account through e-payment portal in single installment.
