Note containing justification for locating the project in Forest Land

Introduction: Indian Oil Corporation Limited (A Government of India Undertaking) was authorised for smooth implementation of City Gas Distribution (CGD) projects. Indian Oil Corporation Limited (IOCL) has been granted an authorization by Petroleum and Natural Gas Regulatory Board (PNGRB) for laying building, operating and expanding City Gas Distribution Network & Compressed Natural Gas (CNG) Outlets in Geographical Area of Bhojpur, Buxar, Jehanabad and Arwal Districts vide authorization dated 29.03.2019.

Indian Oil Corporation Limited is implementing CGD projects in Geographical Area of Bhojpur, Buxar, Jehanabad and Arwal Districts along with various other cities of country under the Petroleum and Natural Gas Regulatory Board (Authorizing entities to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Network) Regulation, 2008.

Justification: This being a City Gas Distribution project, the Natural gas pipeline network will connect major demand centre in city for Domestic connection and to CNG retail Outlets. Natural Gas Pipelines has to be laid along the roads in the city. The network is starting from City Gate station and has to reach the city via shortest routes along the roads. In this particular case, steel pipeline route will originate from GAIL CGS, Naubatpur in Patna District and will traverse along the roads in Patna District to reach Jehanabad in the shortest possible manner. Various section of pipeline comes under protected forest in Patna District, the said proposal is required to be applied for. There is no other alternative to this section in city reaching the Jehanabad city and residential colonies.
