



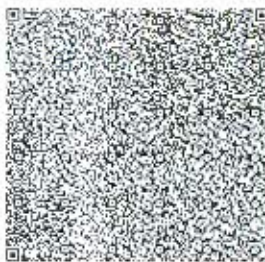

WHEREAS I, **Amresh Kapoor**, am the constituted General attorney of the Indian Oil Corporation Ltd. by virtue of the power of attorney executed in my favour on 14/08/2012.


