- 1. To issue Letter of Intent and Letter of Appointment to the persons to whom Dealership has been awarded in line with the policy of the Corporation.
- To execute Dealership Agreements & various contracts/agreements related to the dealership of petroleum products and operation of petrol pumps with various private. Govt., Semi-Govt. parties and also to execute all connected deeds/papers in relation to award of said dealership.



- To sign and execute sale deed/lease agreement/licence deeds/sub-lease agreement for land for Retail Outlets, SKO sites and sale/distribution of other petroleum products with private, government and semi-government parties on behalf of the Corporation.
