NOW THIS DEED WITNTESSETH AS FOLLOWS: -

- 1. That the first Party, shall hand over the possession of the 51.199 hectares of land mentioned in the schedule herein below, to the Second Party after observing all necessary formalities as per land Acquisition Act and the second Party shall utilize the same for the purpose of Compensatory Afforestation land.
- 2. That the first Party shall have no objection whatsoever towards the second party for utilizing the land for the purpose of Compensatory Afforestation which has been duly handed over to the Second Party.
- 3. That the aforesaid compensation shall be paid by the competent authority and the second party shall make every endeavour to assist the first party to receive the said payment of compensation.
- 4. That the first party shall do all/any act/ acts necessary for effecting a valid transfer of the said land unto the Second Party and shall sign all/any document[s] necessary and shall also appear before any authority/ authorities as and when required for the purpose of effective transfer of the aforesaid forest land.
