१	Legal status of the diverted forest land shall remain unchanged ;	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
२	Compensatory afforestation, over degraded forest land double in extent to the forest land being diverted, shall be raised by the state forest department at the cost of user agency	वनक्षेत्रावर पर्यायी वनीकरणाचा खर्च २०१६८८/- रुपये इतका वनविभागाकडे भरणा करण्यात यावा.

3	The land identified for raising compensatory afforestation shall be depicted on the soil toposheet 1:50000 scale and differential GPS maps of the area proposed for diversion as well as land identified for compensatory afforestation along with soft copies of their kml /shapes file shall be submitted along with compliance report.	पर्यायी वनीकरणसाठी निवडलेल्या आवनत वनक्षेत्र दर्शवणारा 1:50000 या प्रमाणाचा टोपोग्रफिक सादर करण्यात यावे.
4	Special protection measure shall be undertaken of the land identified for CA as examination of the google satellite imagery of the area identified for CA revealed that area is traversed by paths/roads which need ample of protection to prevent further encroachment. Provision of special protection may be included in the CA scheme and the same shall be intimated to the regional office before stage –II approval ;	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
5	The user agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate to the state Forest Department. 6	The state government shall charge the net present value(NPV) of the forest land being diverted under this proposal from the user agency as per orders of the hon'ble supreme court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in writ petition (civil) No. 202/1995 and the guidelines issued by this ministry vide its letter no 5-3/2007-FC dated 05.02.2009 in this regard ;	वळतीकरण करावयाच्या वनक्षेत्राचे नक्त वर्तमान मूल्य रक्कम रु.१२७१४९/- इतके वनविभागाकडे भरणा करण्यात यावे.

8	All The funds received from the user agency under the project, except the funds realized for regeneration / demarcation of safety zone, shall be transferred to ad-hoc CAMPA in the saving bank account pertaining to state concerned	उपरोक्त नमुद रक्कम Ad-hoc CAMPA नवी दिल्ली यांच्या खात्यावर ई-पेमेंट पोर्टलद्वारे भरणा करण्यात यावी.
9	The user agency shall obtain the Environment clearance as per the provision of the Environmental ( protection ) Act, 1986 , if required	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
10	The boundary of the diverted forest land, shall be demarcated on ground at the project cost by erecting four feet high reinforced cement concrete pillars,each inscribed with its serial no, forward and back bearing and distance from pillar to pillar	वळातकरण करावयाच्या वनक्षेत्रासभोवताल आ.सी.सी. पिलर्स बसवणे कामी लागणारी रक्कम वनविभागाकडे भरणा करण्यात यावी.

12	User agency shall provided fuels preferably alternate fuels to the labors and the staff working at the site so as to avoid any damaged and pressure on the nearby Forest area	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
13	The Forest land shall not be used any propose other than that specified in the proposal	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
14	The layout plan of the proposal shall not be changed without the prior approval of the central Gov.	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
15	The Forest land proposed to be diverted shall under no circumstances be transfer to any other agency, department, or person without prior approval of the central government	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.

17	Any tree felling shall be done only when it is unavoidable and that too under stict supervision of the state forest department	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
18	The state government shall ensure that process of settlement of rights under the scheduled tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been completed accordance with the guidelines issued by the MoEF & CC In this regard. Documentary evidences revealed that proceeding of the SDLC have been conducted on 7 .03.2016 and the District Collector has issued certificate on 7 .03.2016 while the meeting of the Gram Sabha was held on 23.12.2016. compliance of Scheduled Tribes and other Traditional Forest Dwellers ( Recognition of Forest Rights) Act, 2006 needs to be ensured by the State Government in accordance with the provision of low as stipulated under the said Act ;	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
19	The user agency in consultation with the State Government shall create and maintain alternate habitat / home for the avifauna, whose nesting trees are to be cleared in this project. Bird's nests artificially made out of eco friendly material shall used in the area, including forest area and human settlement, adjoining the forest area being diverted for the project.	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
20	Construction activities will be taken up as per the components proposed in the proposal and area under construction activities should not exceed 0.2031 ha. 21	The user agency shall submit the half yearly compliance report in respect of the above conditions on 31st July & 31st dec every year to the State Government and to the concerned Regional Office of the ministry regularly.	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.

22	The State Government shall ensure compliance of the mentioned condition and annual report of the same shall be submitted 31 st December every year	अट मान्य असल्याबाबत हमीपत्र सादर करण्यात यावे.
