4. The administrative approval is subject to condition that the expenditure on the work be met during the current financial year i.e. 2017-18 as well as its above mentioned requisite amount are to be adjusted within the approved/revised ceiling of Annual plan 2017-18.
5. The expenditure involved is chargeable to the Major Head 5054-R&B (Plan)-04-ODR-337-98-99-51-16- Construction Stg./Wdg. & a bye pass road for state scheme and total expenditure under it should not exceed the amount that has been placed at your disposal during the current financial year 2017-18.
6. The technical sanction of this work shall precede actual execution. No work shall be allowed to be taken up in anticipation of technical sanction. The competent authority to issue technical sanction shall be responsible in case of violation of this clause 9.5.1 of the Haryana PWD code.
