DEMAND NOTICE

Sub:- APFD – Forest (Conservation) Act,1980 – Diversion of 0.57 Ha of forest land in Compt. No. 815 of Penukonda Addl. I block for laying of 33 KV line from Boxampalli Sub-station to the proposed KIA Motors project site near Ammavaraipalli Village, Penukonda mandal, Ananthapuramu Division, in favour of Divisional Electrical Engineer, Construction Division, APSPDCL, Ananthapuramu – In-Principle (Stage-I) approval accorded – communication – compliance report called for -Reg.

It is to inform that the State Govt. of Andhra Pradesh vide reference 1st cited have accorded in-principle (Stage-I) approval for diversion of 0.57 Ha of forest land in Compt. No. 815 of Penukonda Addl. I block for laying of 33 KV line from Boxampalli Sub-station to the proposed KIA Motors project site near Ammavaraipalli Village, Penukonda mandal, Ananthapuramu Division, in favour of Divisional Electrical Engineer, Construction Division, APSPDCL, Ananthapuramu with the following conditions.

1. The legal status of the forest land shall remain unchanged.
2. The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.
3. The User Agency shall pay the Net Present Value (NPV) of the diverted forest land as per the orders of the Hon'ble Supreme Court, dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995 and as per the orders issued by Government of Andhra Pradesh vide G.O.No.124 EFS&T (For.I) Dept., dated 27.07.2010.
4. The funds received from the user agency towards Net Present Value (NPV) under this project shall be deposited either in SB A/c No. SB01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110 003 (RTGS/IFSC No.CORP0000371).
5. Additional amount of the Net Present Value (NPV) of the diverted forest land, if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the user agency. The user agency shall furnish an undertaking to this effect.

6. Other conditions specified in the Government of India, Ministry of Environment, Forests & Climate Change, letters dated 13.05.2011, 16.06.2011 and 10.12.2012, shall also be complied with by the Prl. Chief Conservator of Forests, Andhra Pradesh, and user agency with which they are concerned.
7. The total forest area utilized for the project shall not exceed 3.582 Ha. In case the land is not taken over by the user agency or the same is not used for the stipulated purpose within a period of two years, then the area shall be taken back by the Forest Department.
8. After receipt of the compliance report of the above conditions, the proposal will be considered for final approval. Transfer of forest land to the user agency shall not be affected prior to the issue of final approval. This approval shall be valid for a period of 5 years. In the event of non-compliance of the above conditions, this approval shall automatically stand revoked.

In this connection, it is requested that an amount of Rs. **3,56,820/-** @ Rs. 6.26 lakh per Ha for 0.57 Ha towards Net Present Value shall be deposited through e-payment mode i.e., challan generated through the ministry's website portal (i.e., www.forestclearance.nic.in) in Adhoc CAMPAs, as per the guidelines issued by the Adhoc CAMPAs, New Delhi letter dated 09.06.2016 communicated vide Prl. CCF letter Rc. No. 45921/2001/FCA-4(i), dated 05.07.2016 and submit e-payment receipt **instead of** depositing in SB A/c No. SB01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003 (RTGS/IFSC No.CORP0000371) and submit the payment receipt to this office for taking further action.

With regard to condition No.5, a certificate is to be furnished as given below.

UNDERTAKING

We hereby undertake to pay an additional amount of the Net Present Value (NPV) of Forest land diverted in the Reserve Forest of Ananthapuramu Division, if any becoming the after finalization of the same by the Hon'ble Supreme Court of India, on receipt of the report from the Expert Committee which shall be charged by the State Government.

Further the user agency is requested to comply with the following in accordance with Government of India instructions issued vide F.No. 7-23/2012-FC, dated 24.07.2016 communicated vide PCCFs Rc. No. 45921/2001/F4, dated 23.08.2013 and publish the orders at the cost of the project proponent and submit the published copies to this office.

- 1) Publish the entire forest clearances granted in verbatim along with the conditions and safeguards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purposes.

- 2) The copies of the Forest Clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days.

It is requested to submit the compliance report on the conditions communicated in the reference 1st cited to this office for obtaining the final approval from the Government.
