Purpose:- Proposal for Construction of approach approach road for Gut No. 253/1 B, to located s factory premises. This area is declared. industrial zone by town planning department.- There are many small scale industries/ factories running and basic amenities are being developed in this industrial area such as 1) Darsh Industries 2) Lilabai Babaurao Rondhal , Viaja Babaurao Rondhal 3) Suniti Enterprises 4) Patil 5) Chakan Casting (Gautam Shah, Parasanna Shah) employing on an average 9 to 20 people, this their levihood depends on this land area. The existing Talegaon Chakan-Shikrapur road is only 56 feet distance from proposed approach road. As the forest area Gut No.252 lies exactly in between the industrial zone and existing. Talegaon Chakan raod. North side of parallel boundary of Forest Gut No.252 is totally built-up by various factories. Hence there is no any alternative non forest land available for proposed approach road. We have examined all other ossible alternatives, but it is not possible to avoid the forest land.
