This has reference to the Special Secretary ECC&F, Chennai letter 1st cited above, wherein raised EDS as under:

1. The provisions of Forest (Conservation) Rules, 2022 shall apply to the proposals submitted online through Parivesh portal and which have not been accepted by the Nodal Officer before 28.06.2022 and as per the Forest (Conservation) Rules, 2022, proposal involving forest land of five hectares or more shall be forwarded by the Nodal Officer (FCA) along with the recommendation of the Project Screening Committee. As the subject proposal has been recommended by the Nodal officer. Additional Principal Chief Conservator of Forests (FCA) on 13.10.2022. I am to request you to clarify the reason for submitting the proposal without the recommendation of Project Screening Committee to Government.

Reply: It is clearly stated that the proposal submitted online through Parivesh portal and which have not been accepted by the Nodal Officer before 28.06.2022 and required recommendation by the Project Screening Committee for proposal involving forest land of five hectares or more as per Forest (Conservation) Rules 2022. The proposal was accepted by the Nodal Officer on 29.06.2021 and requested for submitting hard copies (Timeline detail sheet is hereby enclosed). Accordingly, hard copies were submitted to DFO, Thiruvallur and subsequently acknowledgment receipt of DFO was uploaded in Parivesh Portal on 29.07.2021. Hence, the EDS raised by the Special Secretary ECC&F may not be applicable for instant proposal.


2. As per the format prescribed in Form-I for linear projects in the Comprehensive guidelines of Forest (Conservation) Act, 1980, the District Collector's Certificate in respect of Forest Rights Act, 2006 shall contain the signature along with the Full Name and official seal of the District Collector. However, the User Agency has furnished only the Xerox copy of the said Certificate.

Reply: It is clearly stated in vide reference 3rd cited above, MoEF&CC clarified that as per the provision under Forest (Conservation) amendment rules, 2016 the compliance under FRA is not required for consideration of in-principle approval. This has to be furnished by the State Government for consideration of the proposal by the Ministry for final approval. However, the original FRA certificate along with signature and official seal of the District Collector, Thiruvallur obtained and furnished to Nodal Officer/PCCF Chennai through special messenger on 01.11.2022 (Acknowledge of the receipt is enclosed).

In view of the above, you are hereby requested to accord In-Principle (Stage-I) FC approval at the earliest in the interest of the National Project.






**Sub: Compliance of the Schedule Tribes and Other Traditional Forest Dwellers
(Recognition of Forest Rights) Act, 2006-regarding**

Sir,

I am directed to refer to Forest (Conservation) amendment Rules 2016 as amended on 06th March, 2017 wherein inter-alia it has been provided that:

- (e) *the District Collector shall*
- (i) *complete the process of recognition and vesting of forest rights in accordance with the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (2 of 2007) for the entire forest land indicated in the proposal.*
 - (ii) *obtain consent of each Gram Sabha having jurisdiction over the whole or a part of the forest land indicated in the proposal for the diversion of such forest land and compensatory and ameliorative measures, if any, having understood the purposes and details of diversion, wherever required; and*
 - (iii) *forward his findings in this regard to the Conservator of Forests*
- (f) *the entire process referred to in clause (e) shall be completed by the District Collector within the time period stipulated in these rules for grant of in-principle approval under the Act to the proposal.*
- (g) *the Conservator of Forests shall examine the factual details and feasibility of the proposal, carry out site inspection in case the area of forest land proposed to be diverted is more than forty hectares, and forward the proposal along with his recommendations to the Nodal Office.*

I am also directed to refer to references/communications received from various State Governments seeking clarification on whether FRA certificate is to be submitted before Stage-II compliance or it has been submitted along-with proposal for seeking Stage-I approval.

It is clarified that within the time period stipulated for compliance of stage-I

condition, Deputy Commissioner shall complete the process of compliance of FRA (including forwarding its findings to the concerned CF). Hence for the purpose of the MoEF&CC, as per the provision under Forest (Conservation) amendment rules, 2016 the compliance under FRA is not required for consideration of in-principle approval. This has to be furnished by the state Govt. for consideration of the proposal by the ministry for final approval.

In view of the above, the State Governments are requested to adhere the provisions contained in Forest (Conservation) Amendment Rules, 2016 for FRA purpose while forwarding the proposal for seeking prior approval under Section 2 of Forest(Conservation) Act,1980 to this Ministry for consideration.
