## **Justification for locating the Project in Peddapally Forest Division area:**

Under the provision of the license which entitles us to lay underground OFC for digital India. The Digital India is flagship program of Govt. of India-with a vision to transform India into digitally empowered society and Knowledge economy.

The area requested for the laying of the OFC is the bare minimum considering the requirements and also considering the safety of cables so laid. Since the Telecommunication cables also carry the communication from the government offices , Defense and Strategic establishments, and from the differential industrial organizations apart from the general public, for the safety and confidentiality of the conversation so made it is not advisable to lay such important cables on the private land belonging to different parties.

The cable alignment will be suitable diverted to avoid any cutting of trees and laid within the road land boundary by excavating a narrow trench of 30 cms width. The same strip of trench will be reinstated to its original condition. It is also intimated that no structure will be erected on the cable route.

The project does not involve felling of trees as OFC is laid within the Road Boundary along the Road only.
