Failing which it will be presume that you are not interested in operation of the mining contract area, hence, your selection as user agency for the MCA will be cancelled and allotted to other suitable user agency to avoid any financial loss to the Govt exchequer and crisis of stone for developmental works.

1. Mining plan of the proposed mahal / quarry area.
2. Forest Right Act, 2006 certificate (FRA 2006).
3. SOI Toposheet map (1:50,000 scale) showing the mahal / quarry area along with GPS coordinates.
4. GEO-reference map and KML file of the proposed mahal / quarry area.
5. Undertaking for payment of Net Present Value & additional NPV in non judicial stamp paper.
6. Undertaking for demarcation and construction of boundary pillars, raising afforestation equivalent to one and half time of safety zone area in non judicial stamp paper.

Moreover, you are requested to submit a hard copy of the online proposal i.e. duly filled up Form-A Part-I along with above mentioned documents to the office of the undersigned for my onward necessary action.
