In exercise of the power conferred by Clause (b) of Sub-Section (2) of Section 5 of Mines & Minerals (Regulation & Development) Act, 1957 read with Government of India Order No. S.O. 445 (E) dated 28.04.1987, I hereby APPROVE the above said Modification to Approved Mining Plan. This approval is subject to the following conditions in addition to the conditions imposed while approving Modification to Approved Mining Plan vide letter No 314 (3)/2008-MCCM(CZ)/MP-16 dated 06.10.2008.

- I. The Modification to Approved Mining Plan is approved without prejudice to any other law applicable to the mine area from time to time whether made by the Central Government, State Government or any other authority and without prejudice to any order or direction from any court of competent jurisdiction.
- II. The proposals shown on the plates and/or given in the document is based on the lease map /sketch submitted by the applicant/ lessee and is applicable from the date of approval.
- III. It is clarified that the approval of aforesaid Modification to Approved Mining Plan does not in any way imply the approval of the Government in terms of any other provision of Mines & Minerals (Development & Regulation) Act, 1957, or the Mineral Concession Rules, 1960 and any other laws including Forest (Conservation) Act, 1980, Environment (Protection) Act, 1986 or the rules made there under, Mines Act, 1952 and Rule & Regulations made there under.
