In reference to your letter received through Mining Officer Mandi dated 27.06.2023 on the subject cited above, it is informed that the Government vide letter No. Ind-(F) 6-9/2017-II-Loose dated 25.11.2023 has conveyed the approval for the extension of validity period of Letter of Intent for the auctioned quarry of Son Khad Part-VII over an area measuring 01-54-52 Hect bearing Kh. No. 02/2 (Government land), falling in Mauza & Mohal Sarshkan of Tehsil Dharampur District Mandi H.P. further term of one year w.e.f. 04.06.2023 onwards, in your favour to procure the Environment and other Clearances.

Accordingly, the validity period of Letter of Intent for Son Khad Part-VII over an area measuring 01-54-52 Hect bearing Kh. No. 02/2 (Government land) falling in Mauza & Mohal Sarshkan, Tehsil Dharampur, District Mandi, H.P. is hereby extended for a further term of one year w.e.f. 04.06.2023 onwards, for the purpose of obtaining Environment Clearance/ Forest Clearance from competent authority and completing other codal formalities. The applicant shall not resort to any mining activities till getting the final grant order in this behalf.

LETTER OF INTENT


The Tender-cum-Auction of Minor Mineral Quarries of District Mandi was held on 30.01.2018 by the Auction Committee constituted under the Chairmanship of Additional Deputy Commissioner Mandi, District Mandi H.P. During the auction of Son Khad Part-VII, the highest annual auction bid of Rs. 2,63,000/- (Rs. Two lacs sixty three thousand) only was offered by Sh. Suresh Kumar, S/o Sh. Chaman Lal, Village Bharouri, P.O. & Tehsil Dharampur, District Mandi, H.P. On the basis of recommendation of the Auction Committee, the matter was referred to the Government for approval and as per approval conveyed by the Government vide letter No. Ind.-II-(F)-6-9/2017 dated 11.05.2018, the Letter of Intent for extraction of Sand, Stone & Bajri from Son Khad Part-VII, over an area measuring 01-54-52 Hectares bearing khasra number 02/2 (Government land) falling in Mauza & Mohal Sarshkan of Tehsil Dharampur, District Mandi, H.P. for a period of 15 years is hereby issued subject to the following conditions:-

1. The party shall get the area demarcated from the revenue authorities and shall erect permanent boundary pillars to the satisfaction of the Mining Officer so as to clearly depict the area for which letter of Intent is issued. A copy of the demarcation report shall also be submitted to the Mining Officer concerned.
2. The party shall have to submit the approved Mining Plan under Rule 35 of Himachal Pradesh Minor Minerals (Concession) and Minerals (Prevention of illegal Mining, Transportation and Storage) Rules, 2015.
3. The party shall have to obtain Environment Clearance under the provision of Environment Protection Act, 1986 from the Competent Authority.
4. The party shall pay the 25% amount of the offered bid amount as upfront premium (non-refundable) within one month from date of issue of this Letter of Intent, which shall be adjustable against first quarterly installment of the quarry.

5. The party shall have to obtain Forest Clearance under the forest Conservation Act, 1980 and amendments/notification issued time to time in this regard from the Competent Authority.
6. The party shall have to comply all the notified terms and conditions of auction held on 30.01.2018.

The Letter of Intent is subject to any order passed by the Hon'ble Supreme Court of India/Hon'ble National Green Tribunal/Hon'ble High Court of Himachal Pradesh or other concerned Department from time to time in this regard. This letter of intent is valid only for obtaining requisite clearance from the Competent Authority.

The grant order imposing all the conditions and stipulations relevant as per rule shall be issued only after completion of the above conditions numbers 1 to 6 and after completing requisite codal formalities. This Letter of Intent shall be valid for period of two years. Thereafter, extension of period shall be granted only after reviewing of the progress made for fulfillment of the above said documents. The party shall not resort to any mining activities till the signing of contract agreement.
